Course Objective

The objective of the course is to give students an overview of public policy, policy making process, factors affecting policy design, implementation and outcomes, the role and relationship between government and market, the role of public institutions and governance in economic development, major changes in the global economy that shape the environment and policy outcomes. The course presents some key concepts in public policy research and analysis, applying these concepts to analyze specific policy issues.

The second objective of the course is to equipt students with vital soft skills for their work in policy fields; for instance, critical thinking skills, presentation skills, group work, discussion and writing skills.

Upon course completion, students are expected to have following competencies and skills:

- Understand policy making process and factors affecting the process;
- Participate in discussion and contribute to policy processes;
- Develop critical mindsets for analysis and synthesis;
- Problem-solving skills and make decisions related to policies.

Course Description

The course is centered around 6 themes as follows: (i) policy-making process and factors affecting this process; (ii) institutions and the role of institutions in policy-making; (iii) values and the role of values in shaping public policies; (iv) the role and relationship between government and market; (v) stakeholders and the role of advocacy; and (vi) political economic aspects of public policy.

Students are required to examine reading materials and briefly read through to prepare before the course starts (materials will uploaded/updated on Teams on 10th October 2023, 2 weeks before the course starts).

Class meetings consist of lectures by instructors and class discussions based on case studies. To get a sense of what case studies are and how to write policy memos, students can refer to two guidance from Harvard Kennedy School of Government:

- Learning with case studies, Case Study Program by HKS.
- Guidance on how to write policy memos, HKS Communications Program.

Readings

Readings include chapters in books, some selected readings from other sources and case studies (refer to detailed schedule below). Students must complete required readings before class. Additional readings are not required but recommended for students to develop a broader and deeper understanding of topics and class discussions.

Course Requirements

Students must attend the class diligently, complete required readings before class, actively participate in class discussions and complete all assignments. Students should refer to FSPPM Student Handbook for MPP25.

Evaluation: Students' grades will be based on:

Class participation: 25% (attendance and discussion)

Policy memo: 30% (2 memos, each accounts for 15%)

Group paper: 45% (students allocate work for each member in the group).

The course has a total of 4 case studies. Each student chooses to submit 2/3 policy memos (*Case Study 1 is not included*) based on analytical questions in each case study. Deadline for these memos are 8:20 a.m. Wednesday, 25th October 2023 and Friday, 27th October 2022. The length of a memo must be around 1000 words (± 10%).

Class of MPP24 (including PA and LM) are divided into 14 small groups (students can form groups on their own and inform teaching team of their groups. Each group must not exceed 4 students and work together to complete a short group paper. **Deadline for group paper is 8:20 a.m. Monday, 20**th **November 2022**. The length of the group paper is 2500 words (± 10%).

All papers must be submitted in Word files on Teams as per FSPPM regulations. Students must strictly observe rules related to academic integrity, quote and cite all the reference sources in the right way. All violations on academic integrity will be handled according to procedures specified in Student Handbook for MPP2024. Please be noted that after submission on Teams, all papers will be scanned for similarities and plagiarism using Turniti.

To prepare for Group Paper, students need to follow below schedule:

Before the course:

- From 10-20/10/2023: Students get used to learning via Teams, propose policy issues of their interest and form groups. Each student can only join one group.
- Notes for tutors: Tutors must contact and guide students on how to study and form groups.

During the course::

- On 24/10/2023: Form groups and each group decides their own topics.
- On 25/10/2023: Group discussion on policy contexts and issues (output: 1 page).
- On 26/10/2023: Group discussion on policy questions and factors that affect policy outcomes (output: 1 page).
- On 27/10/2023: Group discussion on Draft proposals (output: 1 page).

After the course:

- On 20/11/2023: Groups submit their papers which range around 2500 words (\pm 10%).
