Inauguration

FSPPM welcomed 69 new cohort MPP2021 students on the Inauguration and Orientation taking place on October 14. There are 34 students in the Policy Analysis concentration and 35 in the Leadership & Management concentration. The students come from 13 cities and provinces in Vietnam with 33% from the public sector, 39% from the private sector, 12% from university & research institutes and 12% from social organizations.

Vietnam Executive Leadership Program December 2-6, 2019

From December 2-6, 2019, FSPPM in partnership with Harvard Kennedy School organized the Vietnam Executive Leadership Program (VELP) 2019 in Boston, U.S. Fifteen Vietnam delegates were led by H.E. Nguyen Van Binh, Politburo member and Head of the Party Central Committee's Economic Commission. Starting from 2008 as a high profile policy forum for Vietnam top leaders and international experts to discuss current global trends relevant to Vietnam future prospects, VELP 2019 explores the implications of cyber security and openness to the economy, utilizing cloud technology to improve public service delivery and institutional reforms.

Outreach

Various initiatives funded by local authorities and organizations have been implemented by the FSPPM Outreach team.

- Project Restructuring the Economic of An Giang Province: Creating a Breakthrough towards the Sustainable Economic Development commissioned by An Giang Provincial Party Committee. A conference for experts' insights on the project will be organized by FSPPM in partnership with An Giang People's Committee in January 2020. The research report is in the final stage of completion for the defense scheduled in February 2020.
- Project The development of Ho Chi Minh City into an international financial center funded by Ho Chi Minh City Finance and Investment State-owned company (HFIC). FSPPM research team was on the final round of discussing about the cooperation agreement between FUV and HFIC.
- Project Toward a Big Urban Data Facility -Computational Investigation of the Connectivity, Resilience and Demand of The Bus Network in Ho Chi Minh City granted by Vin Group Innovation Foundation. The project report for phase 1 (end on December 2019) is on track.








Research
