Teaching team



Vu Thanh Tu Anh

Dean, Fulbright School of Public Policy and Management (FSPPM)

Dr. Vũ Thành Tự Anh has been the Dean of Fulbright School of Public Policy and Management (FSPPM) since 2017. In this capacity, he led the transformation of Fulbright Economics Teaching Program (FETP) into FSPPM, the first public policy school in Southeast Asia accredited by NASPAA (USA).

His research interests include political economy of development, public finance, industrial policy, and institutional economics. He is an author in two recent edited volumes on Vietnam, namely Navigating a Rapidly Changing Economy, Society, and Political Order (Harvard University Press) and Routledge Handbook of Contemporary Vietnam (Routledge). During 2013 – 2015, he was a Global Leaders Fellow at Blavatnik School of Government (University of Oxford) and Woodrow Wilson School (Princeton University).

He was a member of the Economic Advisory Group of Prime Minister Nguyen Xuan Phuc (2017-2021). He has also been a policy advisor to many cities and provinces in Vietnam, including Ho Chi Minh, Hai Phong, and Thua Thien Hue. He holds a Ph.D. degree in economics from Boston College.



Pham Duy Nghia

Director, Master in Public Policy Program

Professor Pham Duy Nghia graduated at Leipzig University (Germany). At FETP he teaches Law and Public Governance, Public Policy and Research Methods of Public Policy. He has published a number of textbooks and journal articles on legal and governance issues. His recent research focuses on good governance, including perspectives on how to enhance the people's participation in policy making and to enhance the efficiency, transparency, and accountability of government.

Pham Duy Nghia is a frequent commentator inleading newspaper and media in Vietnam. The areas concerned include protection of basic citizen's rights, voice and accountability in public governance, regulatory quality, rule of law and access to justice. He is a member is Professional Associations Vietnam International Arbitration Center (VIAC/VCCI), Vietnam Lawyers Association (VLA).

Jonathan Pincus

Economist & Senior Lecturer (FSPPM)

Jonathan Pincus is a development economist specializing in the countries of Southeast Asia. He has held teaching posts in Europe, Asia and North America and various policy advisory roles with multilateral organizations in Vietnam, Indonesia, the Philippines and Myanmar. He was Dean of the Fulbright Economics Teaching Program (FETP), the forerunner of FSPPM, from 2008 to 2013, and helped establish the Rajawali Foundation Institute for Asia at the Harvard Kennedy School. In Indonesia, he has worked with philanthropists and universities to create a network of social science and public policy research institutes affiliated with Northwestern University in the United States and the School of Oriental and African Studies in London.



Nguyen Xuan Thanh

Economist & Senior Lecturer (FSPPM)

Nguyen Xuan Thanh is a senior lecturer in public policy at the Fulbright School of Public Policy and Management. From 2015 to 2023, Thanh was a senior fellow at the Ash Center for Democratic Governance and Innovation, Harvard Kennedy School. Between 2018 and 2021, he served as a member of the Vietnamese Prime Minister Economic Advisory Council. His research interests are macroeconomic management, cross-ownership in the banking sector, and financing infrastructure development. At the Fulbright School, Thanh teaches courses on Introduction to Public Policy, Appraisal of Public Investment, and Policy Implementation. He also teaches regularly in the Fulbright School's executive education and participate in policy dialogues with public sector agencies in Vietnam and Southeast Asia. Thanh earned a BA (Hons) in economics from Delhi University, an MSc in economics and finance from the University of Warwick, and an MPA from Harvard University.



Huynh Trung Dung

Public Policy Faculty Lead (YSEALI) & Lecturer (FSPPM)

Huynh Trung Dung (Dung Huynh) is the Lead Faculty member for Public Policy of the YSEALI Academy and a lecturer of the Fulbright School of Public Policy and Management, Fulbright University Vietnam. Huynh's research interests include Asia-Pacific international relations, political economy, and policy making. From 2016 to 2021 he worked for the RAND Corporation (in California), where he participated in diverse research projects on Indo-Pacific security and defense as well as healthcare policymaking.

Prior to joining RAND, Huynh was a lecturer in public policy, leadership, and strategic management at the Fulbright Economics Teaching Program (currently the FSPPM at Fulbright University Vietnam) and the Royal Melbourne Institute of Technology University (RMIT) Vietnam after working in Vietnam's Ministry of Foreign Affairs for eight years. He holds a Ph.D. in Policy Analysis from the Pardee RAND Graduate School (the U.S.), an M.P.P. from the Lee Kuan Yew School of Public Policy (Singapore) and undergraduate degrees in international relations and economics (Vietnam).
